Official Regulations (Please Read Carefully)

1. An entry fee of \$15.00 for all contestants who return their application on or before June 12th 2010 (postmarked by this date) and \$20.00 for all contestants that return their application after June 12th, 2010. Fee must be turned in with the entry form on or by the July 18th meeting. (There will be no exceptions, cash only please). Photos will be taken at the first two practices, so please come to practice ready for your picture to be taken. This will be a head shot (photo from the waist up). Please remember that this photo will be published in the newspaper. **YOU DO NOT BRING IN A PHOTO.**
2. All entrants must be at least 13 years old, but no more than 15 years old by the contest date.
3. All contestants must be of good reputation and must never have been married or pregnant.
4. All entrants must be residents of the Niles Four Flags Area; Niles, Niles Township, Berrien Springs, Buchanan, Howard Township, or Brandywine.
5. A personal biography of the contestant is to be filled out completely and must accompany the entry form. A biography worksheet is attached to the entry form and information provided will be used for newspaper articles and during the pageant. Please type or use black/blue ink and remember this will be the judge's first impression of you.
6. If chosen Miss. Apple Festival or Jr. Miss. Apple Festival and during your reign you are chosen to represent your community (Any city title that the committee feels would conflict with your Apple Festival obligations, such as an area Blossomtime queen) as the Queen, you will be asked to relinquish your crown to the first runner up.
7. You will be required to provide your Opening number outfit. The outfit requirements will be black pants, black shoes & any bright colored shirt of your choice.
8. Jr. Miss contestant's formal attire should be approximately knee length & dress shoes should have no more than a 2-2 1/2 inch heel.
